

01

03

04

Appoint the relevant team

A specialized team is assigned that matches the type of request, combining the necessary efficiency and experience to ensure that tasks are carried out with high quality.

05

Start implementation

The implementation phase begins based on practical steps and an organized work plan, taking into account the nature and timing of the project, while maintaining continuous coordination.

06
